






Survey: Reasons ID is Needed

Systemic Barriers to ID Access

- 1. Burdensome documentation requirements
- 2. Needlessly high financial costs
 - a. Primary & secondary costs
- 3. Limited availability of ID services
 - a. Hours, locations, physical accessibility
 - b. Transportation
- 4. Confusing patchwork of policies
- 5. Discrimination





- HB 1878 (2022)
- Go Vote Missouri
- Fundamental lack of understanding of lived reality
- Population-specific barriers
 - Immigrant residents of Missouri
 - Transgender and non-binary Missourians
 - Unhoused Missourians



Systemic Solutions in Missouri

- The Missouri State ID Access Coalition is committed to eliminating barriers to official state identification faced by Missouri residents, with a special emphasis on individuals and families experiencing poverty and homelessness.
- Goals
 - Reduce or eliminate the cost of government-issued identification
 - Pursue reforms to ensure equitable access to local Department of Revenue (DOR) office services
 - Expand access to government-issued identification through nongovernmental organizations
 - Cultivate relationships and build power for State and Local legislative change
 - Increase awareness through education and outreach



MO Birth Certificates: Overview

MO Birth Certificates



- Completed Application (notarized if mailing in)
- Identification Document(s)
 - In person: photo ID; OR 2 things with name (letter from agency, mail, selective service verification, agency face sheet)
 - Mail: notarized application
- Payment = \$15
 - In person: Visa, Mastercard, Cash, Business Check
 - Mail: Money Order or Business Check
- St. Louis Vital Records offices:
 - City Hall, 1200 Market Street, Rm. 127, St. Louis 63103
 - St. Louis County Vital Records Office, 6121 N. Hanley Rd, Berkeley, 63134



Who Can Apply for a Missouri Birth Certificate?

- Immediate family members (parents, siblings, and grandparents)
- Official representatives
- Other authorized agents
- Parent listed on the birth certificate
- Guardian
- Foster parents
- Stepparents



Out of State Birth Certificates

Out of State Applications



- Locate state application online
 - Start local (city, county, state often different requirements/processes)
 - Check specific vital records websites for processes and forms
 - Confirm eligibility to apply & required documentation
 - Verify notarization requirements
 - Sign the application
 - Confirm if prepaid return envelope is required or not
- The Birth Certificate will be mailed to the address on the application
 - Processing time: varies by state
 - Follow-up if not received within 8 weeks (offices will not do follow-up)
- The mailing address listed on the application may need to match the address listed on identification documents (depends on the state)
- When in doubt, just call the vital records office!

State ID Access Coalition

Online Birth Certificate Applications

- Online Birth Certificate applications: VitalChek
 - www.vitalchek.com
 - Quicker
 - Useful for clients with limited documentation
 - Is not available for all states
 - Typically more expensive than applying through mail (estimate 3x more)
- Some states have the option to apply online directly through their offices
- Working shared document is available for state-specific details and hints



MO Photo IDs

REAL vs. Non-REAL State IDs

- Acceptable Documents for Non-Real ID
- Acceptable Documents for Real ID
 - Effective May 2025
 - Required for Air Travel and to enter Federal Facilities
- No cost difference between two types of ID
- Differences
 - Missouri Residency Requirements
 - Social Security Number Requirements
- Non-REAL ID is more accessible for many people

***Additional note for clarification: **Nondriver ID vs. Driver's License**

List of Noncommercial Non REAL ID-Compliant Acceptable Documents:

NEW or not previously verified applicants must present one (1) or more of these documents in each of the following categories. Non U.S. citizen applicants must present documents from each category for subsequent applications. Please note that some documents are eligible to be used as both identity and lawful status verification. All commercial driver license (CDL) applicants and commercial learner's permit (CLP) applicants must present two (2) MO residence address documents. refer to the list of acceptable documents for commercial applicants at dor.mo.gov/driver-license/issuance/required-documents-checklist.html for details.

Free ID to Vote

- Every Missouri resident who is eligible to vote is entitled to 1 free state ID for voting purposes
 - Must be 18 or older
 - Cannot currently be on probation or parole
 - Cannot have a felony conviction related to voter fraud
- If eligible, must be requested from a Missouri License Office
- The same ID someone would receive if paying for one (non-real, non-driver MO ID); there is no such thing as a "voter ID"
 - Individual does not have to be registered to vote
 - Individual should say, "I am here for my free ID to vote" at DMV
- Challenges & inconsistencies
 - Lack of effective public communications from Secretary of State
 - Lack of oversight and implementation failures at DMV offices
 - Inconsistencies with duplicate/replacement IDs

Highlight: Transgender Missourians

- Valid & accurate photo ID
- Past: Form 5532
 - Established in 2016 after grassroots advocacy
 - Government form requiring the signature of a physician, therapist or social worker to approve a change in gender designation for a photo ID

• Present:

- Abrupt removal of Form 5532 in early August 2024
- Move to requiring documentation of gender affirming surgery or a court order
- Unclear how this policy will be enacted
- Immediate impact on transgender and nonbinary Missourians



Highlight: Unhoused Missourians

- Proof of Residency requirement
- Past:
 - Lack of "Proof of Missouri Residency" option for people who stay outside, in between places, or anywhere other than an emergency shelter
- Solution: Form 5862
 - ID Access Coalition advocacy to fix this gap and work with the Department of Revenue to create Form 5862 in July 2022
 - Government form that allows a "homeless services provider" to verify an individual's status as an unhoused Missouri resident and offer permission to receive their photo ID to the service provider's address
 - Broad definition of homelessness (42 U.S.C. Section 11302)

ID Access Subgrants 2025

- Purpose: To support the formation and development of State ID and birth certificate assistance clinics/services across the state of Missouri
- Use of Funds
 - To support the cost of needed ID access program resources or supplies
 - Cost of documents, program equipment, or any other reasonable expenditures needed to operate an ID access program, service or event
- Timeline
 - Applications will open online December 1, 2024
 - Applications due via online submission by January 31, 2025
 - Awards announced by February 28, 2025
- Subgrantee Agreement
- Information session to be held virtually December 11, 2024 (register today)
- Up to \$5,000 per organization per year
- Grant period 1/1/2025-12/31/2025 (or less!)
